



LIMITED 10-YEAR N'DURANCE® COMPOSITE WARRANTY (U.S. AND CANADA ONLY)



What N'Durance® products are covered under this limited warranty?

The products covered by this Limited Warranty ("N'Durance® Covered Products") are **N'Durance Universal** (purchased in the United States and Canada) and **N'Durance Cristal** (purchased and available in the United States only). N'Durance® Dimer Core and N'Durance® Dimer Flow are not included.

How long does this limited warranty last?

This Limited Warranty lasts for ten (10) years beginning on the date that the N'Durance® Covered Product was originally purchased.

How long will this limited warranty be available?

This Limited Ten-Year Warranty is available for N'Durance® Covered Products purchased between January 1, 2016 and December 31, 2016.

LIMITED 10-YEAR N'DURANCE® COMPOSITE WARRANTY

(U.S. AND CANADA ONLY)

What is covered under this limited warranty?

Septodont, Inc. ("Septodont") warrants to the original purchaser of an N'Durance® Covered Product (the "Purchaser") that, under normal use, the N'Durance® Covered Product will be free from failure (as defined below). Should an N'Durance® Covered Product failure (as defined below) occur, Septodont will provide the Purchaser with a \$100.00 reimbursement. The exclusive remedy with respect to the N'Durance® Covered Product shall be the \$100.00 reimbursement. LIMITED WARRANTY ONLY AVAILABLE FOR PRODUCTS PURCHASED IN THE UNITED STATES AND CANADA.

For purposes of this limited warranty, "failure" is defined as:

- Composite fractures, cracks, chips or pitting

What does this limited warranty not cover?

This limited warranty does not apply to:

- Composite discoloration, staining, de-bonding, secondary caries or patient sensitivity

How can I receive service under this limited warranty?

To claim the \$100.00 reimbursement, Purchaser should return the three items listed below to the following address: Septodont, 205 Granite Run Drive, Suite 150, Lancaster, PA 17601

- A copy of the original dated purchase invoice from the dental supplier;
- A copy of the original dated patient invoice for the procedure with patient identification information omitted;
- A letter from the dentist certifying (i) the date of the original placement; (ii) a description of the Product failure; and (iii) a statement that the original Product was required to be removed during a replacement.

How do state warranty laws affect this limited warranty?

THE ABOVE WARRANTY IS EXCLUSIVE OF ALL OTHER WARRANTIES, AND SEPTODONT AND ITS AFFILIATES' AND SUPPLIERS' MAKE NO OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION, THE IMPLIED WARRANTY OF MERCHANTABILITY, NON-INFRINGEMENT, OR FITNESS FOR A PARTICULAR PURPOSE. NOTWITHSTANDING THE FOREGOING, HOWEVER, NO WARRANTY OF MERCHANTABILITY, NON-INFRINGEMENT, OR FITNESS FOR A PARTICULAR PURPOSE, IF ANY IS IMPLIED FROM THE SALE OF THE N'DURANCE® COVERED PRODUCT, SHALL EXTEND FOR A LONGER DURATION THAN 10 YEARS FROM THE DATE OF THE N'DURANCE® COVERED PRODUCT PURCHASE. IN NO EVENT SHALL SEPTODONT, ITS AFFILIATES OR SUPPLIERS BE LIABLE TO THE PURCHASER OR ANY OTHER PERSON FOR ANY INCIDENTAL, CONSEQUENTIAL, INDIRECT, SPECIAL, OR PUNITIVE DAMAGES ARISING FROM OR IN ANY WAY CONNECTED WITH THE PURCHASE OR OPERATION OF THE N'DURANCE® COVERED PRODUCT.
